SUPPLY AND INSTALL NEW BOWLING CLUB GREEN LIGHTING AND ASSOCIATED INFRASTRUCTURE

Exclusions

1. Project specific builders' insurance.
2. Building Permit, CDC and demolition permit.
3. Dewatering for all earthworks.
4. Digging in rock, clay and/or foul.
5. Clean Fill.
6. Full site underground services location, only the relevant working areas services will be located.
7. Repairs or modifications to any existing electrical services, cabling or infrastructure that do not form part of the scope of works, deemed non-compliant at the time new lighting installation.
8. New conduit and cabling from the point of supply to the existing light poles.
9. New pole footing for the existing pole locations.
10. Western Power charges and fees over.
11. Upgrade to any existing switchboards.
12. Modification to the existing lighting control system.
13. Tipping and cartage of foul soils, rubbish and/or asbestos.
14. Tipping of overburden and rubble.
15. Asbestos management plan.
16. Work outside Greenlite Electrical standard working hours (7am-4pm Monday-Friday) other than that required for Lux testing.

Notes

1. Our submitted pricing is based on pile footings.
2. This quote is based on utilising the existing pole footings for the 4 new West and Centre poles.
3. We suspect that the lighting is supplied from the new rec centre direction, we anticipate being able to redirect the cabling to the Northern middle pole to the new Northeast pole. This work will require demolishing and reinstating at least 1 x 2m x 2m concrete panel.
4. Based on the photos provided, we anticipate the requirement to trench from the existing South middle pole, along the limestone retaining wall to the new Southeast pole. This work will require demolishing and reinstating at least 2 x 2m x 2m concrete panels.
5. This quote includes as an optional item the reinstatement of three (3) 2m x 2m concrete panels, any reinstatement over and above that allowed will be negotiated with the shire as a variation.
